CNB opens AutoBanks in Northwest area

City National Bank opened a new AutoBank on August 14, at 7806 Olentangy River Road opposite Worthington Hills. Another AutoBank is opening this week at Snouffer and Sawmill Roads, and early in September a third AutoBank will open at 136 W. Bridge St., in Dublin. "The expansion of our AutoBank network is just part of our search to keep making banking better for our customers," Tom Rice (VP-Branch Adm.) said.

The AutoBanks offer drive-in teller service Monday through Friday, from 7 a.m. to 6 p.m. In addition, there is 24-hour self-service banking.

First Banc Group to add Pomeroy affiliate

Pomeroy National Bank's board of directors has agreed to affiliate the bank with the First Banc Group of Ohio, Inc., it was announced by John G. McCoy First Banc Group President.

The \$29 million Pomeroy National is the largest bank in Meigs County with offices in Pomeroy, Rutland, and Tupper Plains. Like Pomeroy National's affiliation, that of Hardin National Bank in Kenton is also pending regulatory and shareholder approval. Pomeroy National would be the 20th First Banc Group affiliate.

First Banc Group's board of directors has approved a third quarter dividend of 41 cents per share, payable on Sept. 28, 1979 to shareholders of record as of Sept. 14.

As of June 30, 1979, First Banc Group reported its 29th consecutive quarter of increased earnings over the previous year. Net operating earnings for the 2nd quarter were \$7,375,989, an 18.4% increase over the same period a year ago. At quarter's end, total resources of First Banc Group reached \$2.414 billion, an 18.9% increase in a year.
